



Sustainability Action for the Environment (SAFE) Fund Application Form

ABOUT THE SAFE FUND

The SAFE Fund was created in 2007 by Royal Roads University faculty member Charles Krusekopf to educate learners about the greenhouse gas (GHG) emissions and other environmental impacts created by travel to their Masters of Environment and Management (MEM) program residency. Students were asked to calculate the GHG emissions associated with their travel to and from their residency and/or the GHG emissions created by their personal travel and lifestyle, and then make a donation to support sustainability projects.

The SAFE Fund was established to promote environmental education and action at Royal Roads, build a culture of sustainability and encourage creativity.

The Fund supports two types of projects:

- 1) Projects that enhance sustainability efforts on the Royal Roads campus;
- 2) “Living Your Learning” projects carried out off campus.

APPLICATION CRITERIA

2018-19 applications will be accepted from current students, staff, faculty, associate faculty and alumni until February 18, 2019. The fund awards up to \$2,500 per application, with two application opportunities annually. **Please note:** the SAFE Fund is meant as seed or supplemental funding and should not be the only source of funding.

Preference will be given to projects that:

- ✓ Engage students, staff and faculty and/or the larger community
- ✓ Have a defined timeframe and specific deliverables that can be overseen by the applicant
- ✓ Are possible and realistic in the scope of the objectives
- ✓ Advance existing sustainability initiatives on campus and a culture of sustainability
- ✓ Promote and/or facilitate applied student projects that demonstrate “living your learning”
- ✓ Promote and/or facilitate collaboration among multiple stakeholders
- ✓ Demonstrate innovative design and implementation
- ✓ ARE NOT part of an existing operating budget

Examples of possible projects include activities to reduce energy use or impact, ecosystem restoration or enhancement, recycling initiatives, transportation alternatives and educational opportunities.
